So, what're we doing?

We're going to work together to create a legacy video, a documentary about your life and times or the life and times of a loved one.

What you'll do

• Provide the stories, recollections and visuals.

What we'll do

- Learn about your goals for the video.
- Find out what stories and recollections you'd like to cover.
- Draft questions and send them to you before the interview recording.
- Schedule the interview(s).
- Record, on video, an interview with you at your home or other location of choice.
- Shoot or scan the visuals you provide.
- Edit your video and deliver it in the format(s) of your choice: custom-engraved flash drives, handheld players, DVDs, and/or Blu-ray discs.

What'll we talk about?

That's up to you. This is your life.

What you'll do

- Think about what you'd like to discuss.
- Fill out a questionnaire we'll provide (optional).

What we'll do

- Spend some time before the interview speaking with you about your life, either via telephone, Zoom, or in person, so we can learn your stories and the draft questions designed specifically for you.
- Create a list of interview questions you can study and think about before your interview.
- Draft a "wish list" of visuals we think will help enhance and illustrate your stories.

What kinds of visuals can we use?

We can use anything that can be shot or scanned and that helps to illustrate the subjects you'll talk about during the interview.

Visuals include:

- Still photos
- Newspaper/magazine clippings
- Diplomas
- Wedding announcements
- Plaques
- Trophies
- Medals
- Paintings
- Drawings
- Letters
- Keepsakes
- Souvenirs
- Childhood toys
- Family videos (or films transferred to video)

What you'll do

- Collect all the visuals that relate to your story. If there are visuals that cannot leave your possession, Family Legacy Video can arrange to shoot or scan the visuals at your location.
- Have these visuals ready on or before the day of the interview shoot, if possible. If that's not possible, not to worry we can make other arrangements.

What we'll do

• Shoot or scan your photos and other visuals. We prefer to take your items and shoot or scan them in our studio and then return them to you. HOWEVER, since we know you may be uncomfortable letting precious items leave your possession, we can arrange to shoot or scan them at or near your location.

What happens on the day of the interview?

- A three to five-person crew arrives with several cases of equipment, including lights, camera, tripod and sound gear.
- You are introduced to the crew.
- The crew stages the equipment and cases in a convenient, out of the way spot.
- The producer and camera person choose the area for your interview.
- The crew sets up the lights and camera gear.
- A friendly make-up artist helps you to look your very best for the camera.
- The producer leads you through the interview.
- After the interview is finished, other footage, if needed, may be shot.
- The crew members remove the equipment and then leave your location as they found it.

What you'll do

- Wear "video friendly" clothing. No intricate patterns or stripes or checks. Nothing bright white, bright yellow, bright red or black. Avoid large and shiny jewelry.
- Provide an area where the equipment cases can be temporarily stored. A garage or any nearby room that isn't being used will do.
- Have fun!

What we'll do

- Arrive on time.
- Be courteous and respectful of your home and property.
- Conduct a thorough interview.
- Enjoy hearing your stories!

What happens after the interview?

- We transcribe your interview(s).
- We may ask you for additional visuals.
- We edit your final video.
- We post previews online with a secure link so you can review, request changes, and approve.
- We create your final deliverables.
